2. Sharma Ambulance Service, a partnership firm under the Partnership Act, 1932 having its Registered office at RZ-C-11/144, Gali No. 2, Mahavir Enclave, New Delhi-110045. through its Authorised Signatory (hereinafter called the Second Party) of the other part.

## ON THIS DEED OF AGREEMENT WITNESSES AS UNDER:

## 1. SERVICES TO BE PROVIDED BY THE SECOND PARTY

1.1 The second Party shall provide the Facilities Management Services at the premises of the first Party at RZ-C-11/144, Gali No. 2, Mahavir Enclave, New Delhi-110045

Note: If Ambulance is available at the time of call from the clinic then only we are liable to provide service other wise clinic has to arrange other vehicle, as we are not on fixed charges on monthly based agreement with Sandhyashi Neuro Panchkarma (BF-45, Near Canara Bank, Shalimar Bagh, Delhi-110088)

## 2. THE SERVICES:

- 2.1 The Second Party shall provide Ambulance Services subject to the fulfillment of terms & conditions of the relevant statutory laws by the First Party
- 2.2 The staff provided by the Second Party shall be well dressed and trained in their respective areas of work. In addition to this they shall be well behaved and courteous to the staff of the First Party. The First Party shall have the right to seek a replacement for any of the staff of the Second Party as and when the First Party feels necessary.
- 2.3 The Second Party shall be responsible for providing the services to the First Party as per the on call by The First Party subject to the payment of the services as per the approved rates.
- 2.4 It shall be the responsibility of the Second Party to ensure that the Ambulance Services performed as per the scope of work.

## 3. PAYMENT TERMS

- 3.1 The Services Provider will raise the monthly bill in the first week of every month and the client will pay the same within 15 days of the bill submission. It is also agreed that Service Provider will pay first month's salary of the staff deployed at site. Salary from second month onwards will be released by service provider only they get previous month payment from the client.
- 3.2 If The First Party disputes any item billed, The First Party shall, within 15 days of receipt of the second Party's invoice, notify the second party of the item disputed failing which it shall be deemed that the First Party has accepted the invoice.
- Such as increase (whether retrospective or prospective) in salaries/wages along with consequential increase in other statutory payments etc. will become payable by The First Party to The Second Party subject to written confirmation from the first party
